Announcement of Architectural Design Competition
for a bridge in Pärnu connecting Raba Street and Lai Street

Pursuant to §30 (1)(3) of the Local Government Organisation Act, §19 (1) of the Pärnu City Council Regulation No. 23 of 20 September 2012 “Rules of Procedure of the Pärnu City Government”, and §19 of the Pärnu City Government Regulation No. 12 of 2 July 2018 “Procurement Procedure of Pärnu City Government”, we hereby:

1. Announce the architectural design competition for a bridge in Pärnu connecting Raba Street and Lai Street (hereinafter **architectural competition**).

2. Approve the location plan of the area of the architectural competition (Annex 1), the Competition Manual (Annex 2), and the Terms of Reference (Annex 3).

5. Establish the costs of the architectural competition as follows:

5.1. The prize fund, including taxes, of EUR 32,000, whereof:

5.1.1 EUR 12,000 for the winner of the design competition;

5.1.2. EUR 8,000 for the second place;

5.1.3. EUR 6,000 for the third place;

5.1.4. two consolation prizes of EUR 3,000 each

5.2. The compensation payable to the Members of the Estonian Association of Architects, the Chartered Engineer and the non-voting member shall be EUR 5,000 (EUR 1,000 each), inclusive of taxes.

6. The Jury shall be served by the Planning Department of the Pärnu City Government.

7. The bridge should be designed in view of the indicative construction cost of EUR 4,000 per square metre, inclusive of VAT.

8. This Order shall enter into force at the time of its publication.
